NAME OF PROJECT: National Rural Water Supply and Sanitation Programme (NRWSSP)

1. The *Handeni District Council* has received financing from Development Partners and the Government of United Republic of Tanzania towards the cost of “**Geophysical survey and drilling of 10 productive boreholes**” and intends to apply portion of the funds to eligible payments under the contract for which this Invitation for Bids is issued.
2. The *Handeni District Council* now invites sealed bids from qualified contractors for specialist contractor drilling Works class V and Above to carry out the following;

3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the Public Procurement Act, 2011 and the Public Procurement (Goods, Works, Non-Consultant Services and Disposal of Public Assets by Tender) Regulations 2013 and its amendments of 2016 and are open to all eligible bidders.
4. Interested eligible bidders may obtain further information from and inspect the bidding documents at the office of the Secretary of Tender Board, **P.O. Box 355, Handeni, Tanzania** by physical visit from 7:30am to 3:30pm on Monday to Friday inclusive except on public holidays.
5. Qualification requirements include: legal status i.e. registered with CRB (**MANDATORY**) should possess class five and Above of CRB registration categories for Specialist Contractor drilling Works, should have qualified and experienced key personnel for administration and execution of the contract, proposed sub-contractors and firms involved (if any) and sound financial status of the bidder(s).

A complete set of Bidding Documents in English, in hard copy and additional sets may be purchased by any interested bidder on address given under paragraph 5 above and upon payment of a non-refundable fee of **Tshs. 100,000** (Tanzanian One hundred thousand only). Payment should be made to the **District Executive Director, Own source collection A/C no.41410000532-NMB Handeni.**
7. All bids in one original plus two copies, properly filled in, and shall be submitted at or before 18th April, 2018 at 11:00hrs.AM local time. Late bids will be rejected. Bids will be opened physically **18th April, 2018 at 11:00 hrs** Local time in the presence of bidders' representatives who choose to attend in person at the Conference Hall, **Handeni District Council**
8. All bids shall be accompanied by a bid securing declaration form in the format provided in the bidding documents.
